

O&G Lease/Drilling Surface greement

SURFACE USE, DAMAGE SETTLEMENT AND RELEASE

This agreement is being made and entered into this \underline{q}^{\star} day of <u>Dec</u>, 2013 by and between **THOMAS PARKE LEWIS** and **SANDRA TYNES LEWIS**, husband and wife (the parties collectively shall be called the "Surface Owner"), and their heirs, legatces, surface lessees, representatives, successors and assigns, whether one or more, whose address is 2085 Street Road, Liberty, Mississippi 39645 and ENCANA OIL & GAS (USA) INC., its successors, affiliates and assigns, whose address is 5851 Legacy Circle, Plano, Texas 75024.

Pursuant to the terms and conditions of that certain Oil, Gas and Mineral Lease, dated March 2, 2012. but made effective August 2, 2012, a Memorandum of Oil, Gas and Mineral Lease is recorded in Volume 214 Page 307 of the Official Records of Amite County, Mississippi, Encana has the right to drill, complete, operate and abandon the Lewis 7-18H-1 well located on property owned by the Surface Owner.

In consideration of the sum of (Twenty-One Thousand Sixty-three Dollars and 05/100) (\$ 21,063,05) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Encana is hereby granted the right to construct, install and maintain the drill site, pits, pumps, compressors, tanks, roads, and all appurtenant facilities and equipment necessary for the drilling, completion, operation and abandonment of the Lewis 7-18II-1 well. The undersigned does hereby release and discharge Encana, its successors, assigns, agents, contractors, and employees, from all damages, claims, causes of action and demands, and all reasonably foreseeable loss, damage or injury to property resulting from the construction, drilling, completion, operation and abandonment of the Lewis 7-18H-1 well.

It is understood by the Surface Owner and Encana that the following stipulations apply to this agreement:

- 1. All fences that are removed must be taken down and not pushed into a debris pile.
- 2. Encana shall build a 4-foot (4') net wire fence with two (2) strands of barbed wire on top of the net wire, around the drill site.
- 3. Encana agrees to install two (2) cattle guards and three (3) gates along the access road to the Pad.

and ENCANA OIL & GAS (USA) INC., whose mailing address is 14001 N. Dallas Parkway, Suite 1100, Dallas, Texas 75240, as lessee,

WITNESSETH:

 L Lessor, in consideration of <u>Ten Dollars (\$10.00) & Other Valuable Consideration</u> receipt of w acknowledged, and of the covenants and agreements of lessee hereinafter contained, does hereby grant, lease and let unto lessee the land cove the purposes and with the exclusive right of exploring, drilling, mining and operating for, producing and owning oil, gas, sulphur and all ot (whether or not similar to those mentioned), together with the right to make surveys on said land, lay pipe lines, establish and utilize surface or subsurface disposal of salt water, construct roads and bridges, dig canals, build tanks, power stations, power lines, telephone lin houses and other structures on said land, necessary or useful in lessee's operations in exploring, drilling for, producing, treating transporting minerals produced from the land covered hereby or any other land adjacent thereto. The land covered hereby, herei land", is located in the County of Amite , State of Mississippi , and is described as follows:

TOWNSHIP I NORTH, RANGE 4 EAST

SEE EXHIBIT "A" ATTACHED HERETO AND MADE A PART HEREOF FOR PROPERTY DESCRIPTION AND ADDITIONAL PROVISIONS.

It is intention of the Lessor-to-lease-to-the Lessee, and the Lessor-does hereby-lease-to-the Lessee all-mineral interests owned by I Section(s) described herein whether correctly described herein or not.

This lease also covers and includes, in addition to that above described, all land, if any contiguous or adjacent to or adjoining the land above day in under a landed or claimed by lessor by limitation, prescription, possession, reversion or unrecorded instrument or (b) as to which lessor has a prefere adjustion. Lessor agrees to execute any supplemental instrument requested by lessee for a more complete or accurate description of said land.
